

## BioAsia kicks off with partnerships and collaborations

~ The Project NATURINDIA: "Development of Nutraceutical Extracts and Food Supplements based on the Systematization of Indian System of Medicine", between the Spanish Company Plantas Medicinales de Catalu±a and the Indian Company, Natural Remedies.

~ The Project FUNFRUT: "Development of a Novel Process Technology for the Commercial Production of Sugar-Free Fruit Juices and Study of the End Product Functional Effect" between the Spanish Company Biopolis, S.L. and Indian partners Loyola College and TVN Health Products Company.
