### 1. Information We Collect

We collect personal information about you when you provide it to us or when you use the Website. The personal information we collect may include:

- Information you provide in response to surveys, questionnaires, or other forms on the Website

We may also share aggregated or de-identified information that does not personally identify you with third parties for any lawful purpose.

### 4. Cookies and Similar Technologies

We use cookies and similar technologies to collect information about your use of the Website. Cookies are small data files that are stored on your device when you visit the Website. They allow us to recognize your device, customize your experience on the Website, and analyze how you use the Website.

You can control the use of cookies through your browser settings. However, disabling cookies may limit your ability to use certain features of the Website.

### 5. Data Security

We take reasonable measures to protect your personal information from unauthorized access, use, and disclosure.

BioSpectrum Asia's privacy policy outlines their commitment to complying with major data protection regulations, including the General Data Protection Regulation (GDPR) of the European Union, the California Consumer Privacy Act (CCPA) of the United States, and China's Personal Information Protection Law (PIPL).

**General Data Protection Regulation (GDPR):** The GDPR is a comprehensive data protection law in the European Union that governs the collection, processing, and storage of personal data of EU citizens. It grants individuals rights over their personal data and imposes obligations on organizations to ensure data protection and privacy.

**California Consumer Privacy Act (CCPA):** The CCPA is a state-level privacy law in California, USA, that provides residents with rights regarding their personal information, including the right to know what personal data is collected, the right to delete personal data, and the right to opt-out of the sale of personal data.

**China's Personal Information Protection Law (PIPL):** The PIPL is China's first comprehensive data privacy law, effective from November 1, 2021. It regulates the processing of personal information of individuals within China and has extraterritorial applicability, meaning it can apply to organizations outside China that process the personal information of individuals located in China. The PIPL emphasizes principles such as transparency, purpose limitation, data minimization, accuracy, security, and accountability.

By adhering to these regulations, BioSpectrum Asia demonstrates its commitment to protecting user data and ensuring compliance with international data protection standards.
